**EXECUTIVE SUMMARY:** The purpose of this paper is to update the Police and Crime Commissioners in relation to an amendment to the EMSOU - Forensic Services business case, and in particular the proposed Regional Drugs Analysis Laboratory. The business case for the delivery of a 5 force forensic service in the East Midlands was considered by the DCCs in August 2013 and is now in the implementation phase.

One element of this case included the delivery of an accredited regional drugs analysis laboratory, which was to be based in Northants. The proposal to site the laboratory within Northants was based on a number of factors which were relevant at that time.

However, since this decision was taken there have been a number of events which have required this to be re-visited. In light of these developments the decision to build the Drugs Laboratory within Wootton Hall was reviewed and a series of options were presented for consideration by the DCCs Board.

The option to locate the laboratory at The Arrow Centre was supported and has since been ratified by the regional Chief Constables on 25<sup>th</sup> April 2014 and police and crime Commissioners are asked to note this change to the original business case.
