**TITLE: Additional 2015-6 Community Safety Fund grant for Re:guard project**

**EXECUTIVE SUMMARY:**

The PCC has agreed to award £498 to Nottingham Women's Centre to support further work to follow up the Re:guard project funded by his 2015-6 Community Safety Fund.

The project will be supported by community safety grant.

**INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

A business case has been submitted and considered by the Commissioner. Discussions at the Safer for Women Summit, delivered by the Re:guard project, focused on the need for modern and accessible ways of engaging with women who have experienced misogynistic hate crime but are not aware of their options for reporting to the police or are aware but do not wish to do so, but still want their experience to be logged and validated.

The funding will support Hollaback, a partner in the Re:guard project, to continue its local work to engage with women who have experienced misogynistic hate crime, particularly in student communities.
