**TITLE:** Acquisition of the upper car park and associated land at Burntstump Country Park

**EXECUTIVE SUMMARY:**

It is proposed to acquire the upper car park and associated land at Burntstump Country Park, Arnold, as shown edged in red on the plan at Appendix 1, from Gedling Borough Council.

**INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

At the meeting of the Force Executive Board on 4th September, 2017, the Business Case to construct a new building comprising Control Room, Training Centre, Canteen, Lockers, Showers and Gymnasium was approved.

The Business Case set out the need for additional parking which would arise from the construction and use of the new building on the Sherwood Lodge site and put forward proposals to both increase the number of parking spaces available within the site and to acquire the adjacent upper car park at Burntstump Country Park from Gedling Borough Council.

The upper car park at Burntstump Country Park comprises 49 car parking spaces and is tarmac surfaced. It is accessed from a tarmac surfaced drive, shown coloured blue on the plan at Appendix 1, which runs off Sherwood Lodge Drive close to the gate house entrance to Sherwood Lodge. The car park is under-utilised except at Summer weekends and Bank Holidays due to the availability of the more popular lower car park which is situated adjacent to the Park Hospital.

The opportunity to acquire the upper car park has now arisen, subject to the extinguishment of the formal Car Parking Order which allows the public to utilise the car park throughout the week and governs the terms and conditions (including charges) for this usage.

In indicating its willingness to sell the land, Gedling Borough Council has insisted that this is subject to public car parking continuing to be allowed at weekends and Bank Holidays between April and September each year. The Council will assume full responsibility for the public parking during these periods and will manage the public parking and provide appropriate indemnities. The Council will also contribute towards the future maintenance costs of the car park to reflect the element of public use.


