TITLE: Community Safety Grant 2018-19

EXECUTIVE SUMMARY:

The PCC is requested to confirm his verbal agreement to use 2018-19 Community Safety Grant to:

1. Award up to £1,098,557 of the Community Safety Grant to the Nottingham Crime and Drugs Partnership (CDP), subject to a satisfactory delivery plan, to include the following areas of work:
 - Criminal justice substance misuse services: up to £296,513
 - Substance misuse service for young people: up to £28,284
 - Contribution towards the cost of Castle Gate House: up to £100,000
 - Contribution towards IOM IDVA work: up to £60,000
 - Contribution towards Redthread: up to £35,000
 - Discretionary spend to be aligned with CDP and Police and Crime Plan strategic priorities: up to £578,760.

2. Award up to £625,118 of the Community Safety Grant to the Safer Nottinghamshire Board (SNB), subject to a satisfactory delivery plan, to include the following areas of work:
 - Neighbourhood working: up to £270,750
 - Contribution towards IOM IDVA work: up to £50,000
 - Discretionary spend to be aligned to the wider SNB Strategy and Police and Crime Plan strategic priorities: up to £304,368.

3. Award up to £260,663.16 of the Community Safety Grant in small grants to 18 third sector organisations through the 2018-19 Community Safety Fund to fund the following objectives:
 - Community led early help services and problem solving approaches for people suffering from mental ill health where there is clear evidence of either a link with offending, anti-social behaviour, substance misuse or risk of harm/victimisation.
 - Community projects working to address the complex needs of offenders who are at risk of street homelessness or street drinking.
 - Community led initiatives to prevent hate crime and raise public awareness.
 - Community led initiatives to help identify, tackle and reduce hidden harm, including human trafficking, and crimes impacting upon those least likely to report to the police – such as young people and Black, Asian and minority ethnic and new and emerging communities.

- Programmes to raise awareness and keep people safe online, focusing on preventing child exploitation, bullying, sexting, technologically-assisted harmful sexual behaviour, fraud and other forms of cyber-crime.
 - Targeted programmes and activity to divert children and young people away from crime and anti-social behaviour. Priority consideration will be given to applications that seek to reduce and prevent weapon-enabled violence such as knife crime among young people.
 - Community led initiatives to reduce serious acquisitive crimes, such as vehicle crime and domestic burglary, including traditional evidence-led target hardening activity.
 - Community level problem-solving approaches to address the issues that impact upon and matter the most to local people, including rural crime, motorcycle nuisance and alcohol related anti-social behaviour.
 - Community led initiatives that promote community cohesion, strengthen sense of belonging within communities and empower local people to help achieve their ambitions.
 - Targeted education and awareness raising initiatives with young people, parents and the wider community with regard to substance misuse, including New Psychoactive Substances.
 - Community led initiatives working in partnership with Nottinghamshire Police to facilitate positive relationships between BME and/or new and emerging communities and Nottinghamshire Police.
4. Award up to £15,000 of the Community Safety Grant for 2018/19 (and £10,000 in 2017/18) to Nottinghamshire Community Foundation as a donation to the match funding for the Youth Social Action Fund/ #iwill Programme. The aim of the Youth Social Action Fund is to increase youth volunteering and social action. Local groups can apply to Nottinghamshire Community Foundation for small grants for youth social action projects.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

In previous years the PCC has awarded community safety grants to the Nottingham Crime and Drugs Partnership and the Safer Nottinghamshire Board to lead and deliver initiatives to achieve the strategic goals in the Nottinghamshire Police & Crime Plan. He has also supported the third sector to deliver initiatives through his Community Safety Fund.

Grant to the CDP and SNB (nos 1 and 2 above)

The CDP and SNB are key partners for the PCC. The grant will fund work to deliver the goals in the Nottinghamshire Police and Crime Plan.

Community Safety Fund (no 3 above)

The small grant recipients were selected through a robust assessment process in which all applications were assessed by two officers from NOPCC against a scored matrix. A draft funding list was submitted to an independent funding panel which included senior police officers, representatives from the CDP and SNB as well as expert input from specialists (eg hate crime) where required. The panel agreed the final list of recommendations which went to the PCC. The PCC agreed that 18 projects would be funded to a total value of £260,663.16. The projects are outlined in the attached list, which is also available on the PCC's website.
