**EXECUTIVE SUMMARY:****1. PURPOSE OF THE REPORT**

The purpose of the report is to seek approval to vary Contract **CN1001780 Archive Storage Replacement and Polit Move**. The contract was awarded in March 2018 ref Decision Form **2018.028**.

**2. BACKGROUND INFORMATION**

A further requirement of Network Switches was initiated. These should have been procured through Contract **CN1001780**, however no provision was made for these. The recommendation is to vary contract CN1001780 to include them.

EMSCU have reviewed the procurement strategy and have concluded that a variation with the existing supplier is the most appropriate route within these circumstances.

The varied Contract total would be £441,361.00 plus the additional support that will quoted each financial year.
