Prisoner Intelligence Notification System (PINS) is a software solution designed to help law enforcement agencies prevent crimes committed by offenders when they are released from prison. By pro-actively notifying local police and agencies in advance of release, PINS helps them keep on top of known criminals as they re-enter the community. Procured utilising G-Cloud 10 Framework by Crown Commercial Services (CCS), Nottinghamshire Police has acted as the Lead Force procuring the system for Derbyshire, Leicestershire, and Lincolnshire & Northamptonshire Police for a period of 2 years from 1<sup>st</sup> September 2018 to 31<sup>st</sup> August 2020 with 2 x 12 month optional extensions.


