**TITLE: Consultancy support for Misogyny Scheme**

### EXECUTIVE SUMMARY:

Nottinghamshire Police was the first force in the country to adopt misogyny as a hate crime. Funding is requested to provide consultancy support from Star Fish consulting to enable the national adoption of the Nottinghamshire model.

The contract will run until June 2020 allowing for 18 days consultancy work plus expenses over this period. Funding is requested up to £10,260 to support this work.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

In relation to this contract, the work has been awarded directly to Star Fish consulting as they have delivered work previously for the PCC and have the necessary connections within the field and prior knowledge of the Nottinghamshire Misogyny Scheme to enable them to carry out this work.

The consultancy days will only be used to support the following activities and deliverables:

- Supporting and enabling the National Police Chief's Council (NPCC) to adopt the Nottinghamshire's Misogyny scheme.
- Briefing and gaining support from individual forces to adopt the Nottinghamshire Misogyny scheme locally and at a national level.
- Sharing best practice by speaking at conferences and undertaking media work.


