This Decision Record relates to the approval of a contract to provide an Appropriate Adult service for vulnerable adult suspects, by attending police custody suites and other sites in support of vulnerable adult suspects in custody. This includes people with mental health issues, learning difficulties, problems with substance misuse, reading and writing difficulties. The role of the Appropriate Adult is to ensure that detainee's rights and entitlements are upheld and to facilitate communication.


