TITLE: Serious Violence Risk factors - Advanced analytics

EXECUTIVE SUMMARY:

Nottingham CDP seek £2,000 funding for Nottingham University to explore statistical models (using partner data) to better understand cohorts of young people that are at a greater risk of youth violence and/or criminal exploitation. This will involve an in-depth analysis of a large number of variables that have known links to youth violence. The work will be overseen by Analysis and Insight (NCC) in collaboration with Nottingham University.

Outcomes of the analysis are expected to contribute to a reduction in youth violence through earlier identification – allowing the appropriate body to implement an intervention to individuals that are deemed to be high risk.

This work is a critical component in the move towards machine learning, and will enable more efficient, effective and evidence-led early intervention. Ultimately, it is anticipated that the approach will enable earlier identification of high and emerging high risk individuals to inform the provision of targeted support and intervention.

Delivery timescales for this work are dependent on gaining access to information held on Police systems, however, it is anticipated that analysis will be completed during the 2019 calendar year, with a view to making the prioritisation tool could be available by the end of December 2019. Discussions with Nottinghamshire Police data protection officers commenced in early June.
