TITLE: Chief Constable's Contract Extension

EXECUTIVE SUMMARY:

Mr Guildford was appointed to the position of Chief Constable on 1st February 2017 on an initial four year contract. His current contract is due to expire at midnight on 31st January 2021.

The Police and Crime Commissioner has reviewed Mr Guildford's contract and has decided to offer him a further three years, plus a another one year and then 5 months to run consecutively. This will extend Mr Guildford's contract until July 2025. In addition he has decided to up lift Mr Guildford's salary in line with police regulations and the flexibility available to the Police and Crime Commissioner. In making the decision to extend Mr Guildford's contract at this point, the Police and Crime Commissioner has taken account of the need for strong sustainable leadership to drive continuing success of Nottinghamshire police into the longer term. The contract extension will remove any uncertainty, secure and enable Mr Guildford to plan into the long term for his family in continuance of his commitment to the people of Nottinghamshire.

In reviewing Mr Guildford's contract the Police and Crime Commissioner has agreed and revised a set of personal objectives, which will be reviewed on an annual basis.
