**TITLE: YOUTH COMMISSION 2019/20**

**EXECUTIVE SUMMARY:**

The PCC plans provide funding to Leaders Unlocked to deliver targeted engagement with young people and under-represented groups across Nottinghamshire throughout 2019/20. 20-25 young people aged 14 to 25 will be recruited and trained to join the Youth Commission. The Youth Commission will engage young people from diverse backgrounds including harder-to-reach groups such as ex-offenders.

**INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)**

Having successfully delivered a range of projects since 2016/17 and embedded their delivery model among local youth leaders, the PCC is keen to maintain the continuity of engagement with and support to youth commission members that has been established to date. The PCC also recognises the additional value offered via the Leaders Unlocked national infrastructure which has led to sharing of ideas and good practice among other national Youth Commissions and the involvement of Nottinghamshire members in relevant national programmes of activity.
