TITLE: Joint Police and Partnership Problem Solving Training

EXECUTIVE SUMMARY:

A decision to provide £16,800 to fund Problem Solving training for Police Officers, Police Staff and Partners in support of a recommendation arising out of the Neighbourhood Policing review to reinvigorate effective partnership working and support activity to reduce high severity crime in high harm localities.

INFORMATION IN SUPPORT OF DECISION:

- An external trainer Sylvia Chenary of Applied Criminology Associates has been selected to undertake the training
- Training will be delivered in line with Neighbourhood Policing guidelines and the National Crime Prevention Plan.
- Each attendee will undergo 2 days training
- Each training event will consist of both Police officers, Police staff and partners
- There will be 14 training sessions attended by 520 staff (400 Police officers/Police Staff and 120 partners)
- The first two training sessions will commence in December 2019 and continue in January through to March 2020
- Training sessions will be held on Monday and Tuesdays and then Wednesday and Thursdays
- Each session will consist of 40 people on each course to ensure maximise attendance
- There are longer terms plans to train the trainers to ensure to help sustain the learning
- The Force lead for this area of work Chief Inspector Kathryn Craner attended the Safer Nottinghamshire Board to solicit support from partners to help facilitate attendees and also secure suitable training venues.
