**TITLE:** New Adult Sexual Assault Referral Centre

**EXECUTIVE SUMMARY:**

The 2019-24 Capital Programme which was presented and approved at the Police and Crime Panel meeting on 7<sup>th</sup> February 2019, approved a budget for the replacement adult SARC to the value of £1.0m in 2020-21 and £0.5m in 2021-22.

A detailed business case is in the process of being reviewed and ultimately approved, which will make the financial requirements clear, however in the meantime feasibility and assessment work is being undertaken that needs to be managed against the approved capital programme.


It is therefore requested that £200k of the £1.0m from 2020-21 be brought forward into the 2019-20 capital budget to off-set these preliminary charges.


