TITLE: Award of Social Media Violence Reduction Awareness Campaign Contract

#### **EXECUTIVE SUMMARY:**

The PCC is requested to approve the award of the contract to deliver a Social Media Violence Reduction Awareness Campaign aimed at and coproduced with young people aged 15-25 years by 31<sup>st</sup> March 2020. This work is being funded via Early Intervention Youth Funding as set out in the Notice of Decision ref 2019.045.

Following a procurement process, which was managed by East Midlands Strategic Commercial Unit (EMSCU) a tender panel met on 14<sup>th</sup> November and agreed to:

 Accept the bid from Powell and Barns Group Ltd to deliver a social media violence reduction awareness campaign.

The contract will run from the period 29 November 2019 to 31 March 2020. The total value of the contract to 31 March 2020 is £37,204.

## INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A Request for Quotation (RFQ) was issued through Bluelight in November 2019. The procurement had a financial ceiling of £45,000. Bids were evaluated against published criteria by a panel with the winning bid from Powell and Barns Group Ltd scoring higher marks on both quality and price.
