**TITLE: Slavery and Exploitation Team (SERAC)**

### EXECUTIVE SUMMARY:

There is an emerging pattern of slavery and exploitation in the City and more widely. An interim response has been introduced through a Slavery and Exploitation Risk Arrangements Conference, chaired by DS Austin Fuller and supported by the Council Modern Slavery Team. Home Office funding for the Team ends in January 2020 and the PCC has committed £16,000 to extend the funding of the Team to the end of March 2020 while discussions take place between PCC, City Council and other members of the Modern Slavery Partnership about the provision of a longer term solution.

### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

Tackling slavery and exploitation and protecting vulnerable people remains a priority for the PCC. The project supports delivery of the PCC's Police and Crime Plan. The Anti-Slavery Partnership recognises the SERAC as a case conferencing model that is attracting interest from the Home Office.
