#### **EXECUTIVE SUMMARY:**

As outlined in Notice of Decision 2021.071, Commissioner Henry published a Request for Proposals for an independent review of the functions, roles and responsibilities of staff within the Office for the Police and Crime Commissioner.

Four bids were received which were assessed by the Commissioner and OPCC staff against published criteria. Julia Mulligan's bid received the highest overall marks.

Following assessment of the received bids, Commissioner Henry is requested to approve the award of the contract to deliver the independent review to Julia Mulligan. The contract will cost £20,600 and will be funded out of PCC reserves.

#### **INFORMATION IN SUPPORT OF DECISION:** (eg report or business case)

Commissioner Henry's Contract Standing Orders require 3 quotes for activity under £25,000. The Request for Proposals was circulated via national associations for PCCs and Chief Executives and Solace.

Four compliant bids were received and were assessed against criteria published in the Request for Proposals. The winning bid achieved the highest score and is therefore recommended for contract award.
