#### **EXECUTIVE SUMMARY:**

The Nottinghamshire Police and Crime Survey is a key product used to inform planning and performance by the OPCC, police and community safety partners. The contract for the Police and Crime Survey was awarded to Information by Design and expired at the end of July 2021.

Moving forwards, the Commissioner intends to undertake a competitive tendering process as part of a multi-year contract. However due to the timescales this has not been possible since the Commissioner was elected in May 2021. Therefore in order to ensure continuity and to enable the Commissioner to review the survey and explore her requirements going forward the Commissioner has taken the decision to extend the current contract with Information By Design from 1st August 2021 to 31 March 2022.

This extension will enable time for a full and effective procurement process to take place aligned to the financial year. This will consider opportunities to increase the use of digital techniques to maximise reach and response rates across force area whilst maintaining a robust and representative approach.

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

As detailed above the current contract with Information By Design expired in July 2021. It is proposed that the contract for this longitudinal social research programme is extended from 1<sup>st</sup> August 2021 to 31 March 2022 at a cost of up to £29,898. This would enable a comprehensive procurement process to take place aligned to the financial year.

Having sought legal advice, this extension will be undertaken under regulation 32 (c) of the PCR 2015 and the fact that unforeseen events have meant that a new tender exercise has not been possible. These unforeseen events include the delayed PCC elections which took place in May 2021 and the subsequent change in PCC in Nottinghamshire. The current reduced level of capacity within the procurement team to undertake a full tender exercise has also impacted on this.

The extension has been put in place for the shortest time possible to realistically allow time for a full procurement exercise to take place with potential TUPE implications. It will also enable a short amount of time for the new Commissioner to undertake a review of the current provision and explore any additional revisions for the specification moving forwards,
