### EXECUTIVE SUMMARY:

The purpose of this report is to recommend approval of the renewal of the HOLMES (Home Office Large Major Enquiry System) 2 licensing agreement for a minimum of three years. As per the terms of the HOLMES 2 framework contract (negotiated by Police Scotland and ratified by the NPCC), the period will be made up of the core two years, plus the first of two 12-month renewal options (the terms of the framework require 23 months advance notice of the adoption of the first extension period, hence it forming part of this report and associated approvals.

The system and platform continue to be provided by Unisys.

The cost for the initial two year term is £381,581 and the first one-year extension period is forecast at £168,300. Each regional force will pay (each has confirmed budget availability and term commitment) a proportional split of these costs:

Derbyshire	21.80%
Leicestershire	22.90%
Lincolnshire	13.20%
Northamptonshire	14.80%
Nottinghamshire	27.30%

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

HOLMES is used by EMSOU-Major Crime to investigate major crimes and complex investigations. It is also used by the forces for other investigations such as fraud and historic child sex abuse cases and would be used to manage a Casualty Bureau in the event of a disaster where members of the public were injured or deceased.


