EXECUTIVE SUMMARY:

Nottinghamshire Office of the Police and Crime Commissioner secured funding via the Home Office Safer Streets Grant funding to cover target hardening activities. The grant funding has a time restriction in the need for it to be spent by 31st March 2022.

The activity was sourced via the compliant Fusion 21 framework with an award being made to J Tomlinson.

The amount allocated to this contract is up to £484,006 but the spend against this will be dependent on requirements. The period of contract shall be 1st October 2021 to 31st March 2022.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

Nottinghamshire Office of the Police and Crime Commissioner secured funding via the Home Office Safer Streets Grant funding to cover target hardening activities. The grant funding has a time restriction in the need for it to be spent by 31st March 2022.

A review of frameworks identified Fusion 21 Framework as a route to market with specialist local suppliers who could deliver the services. In conjunction with Fusion 21, the supplier J Tomlinson were identified as the only credible supplier to provide the services. They are also a local supplier so can provide swift response times.

There is already another contract running with J Tomlinson with similar activity (CN1002574) but this could not be varied to capture this amount of funding due to the guidance under regulation 72 of the Public Contract Regulations 2015.
