#### **EXECUTIVE SUMMARY:**

Purple Flag is an accreditation process similar to Green Flag Award for parks and Blue Flag for beaches. It leads to Purple Flag status for town centres that meet or surpass the standards of excellence in managing the evening and night-time economy. Nottingham has held Purple Flag status for its city centre since 2010.

Every two years there is an external assessment process in order to ensure that standards have been maintained and that previous recommendations have been acted upon. The previous external assessment in 2019 highlighted that Nottingham needed to improve the way that it markets its Purple Flag status.

The latest assessment is due in the last quarter of 2021 and Nottingham Business Improvement District have asked the PCC to provide £3,500 to support activities to promote the city's Purple Flag status. Activities will be carried out under the joint branding of the organisations involved. The BID will provide all resource for completion of the Purple Flag application and promotion and the PCC will provide funding to resource and execute the marketing strategy. The £3,500 will be paid from the Nottingham Late Night Levy fund.

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The investment is required because Purple Flag marketing was an area highlighted as being in need of improvement at the last external assessment

This year a full assessment is required to maintain Purple Flag status. Research indicates that Purple Flag can bring a range of benefits which include:

- A raised profile and an improved public image for the location
- · A wider patronage, increased expenditure
- · Lower crime and anti-social behaviour
- · A more successful mixed-use economy in the longer term
- · Increase visitors to our leisure industry
- · Make the NTE safer and more inclusive for citizens and visitors

Part of the assessment criteria focusses on the profile of Purple Flag in Nottingham. This includes the scale of publicity, awareness and public involvement generated for Purple Flag, how it was promoted and plans going forward. The aim of the programme is to educate both businesses and the public regarding Purple Flag and to highlight how safe and well managed the Night Time Economy in Nottingham is as a result.

The intention is to host two Purple Flag stalls and offer flyers with QR codes linking to the BID website, which will have more information on Purple Flag. Planned expenditure is as follows:

Nottingham BID have not been able to budget for Purple Flag promotion events this year due to difficulties with levy income from businesses during the pandemic causing a consequent reduction in activities. In addition to the activities funded by the PCC Purple Flag will also be promoted through social media and digital channels, for its City Centre since 2010.
