EXECUTIVE SUMMARY:

- To provide a daily account manager to ensure content is posted in a timely manner. To provide a

- To write, design, produce and send a monthly e-newsletter detailing the work of the Commissioner, including all graphics
- To include temporary offline communications support as and when required including the writing and distribution of press releases during periods of existing Communications support absence due to leave or illness.
