## **EXECUTIVE SUMMARY:**

Further to Decision Record 2021.015 the Sexual Violence Mental Health Practitioner Pilot started in May 2021 and will run until 31<sup>st</sup> August 2022. The Pilot involves seconding a SVA Mental Health Practitioner into specialist SVA services to provide specialist assessment and assess to mental health interventions for sexual violence survivors as well as raising awareness and building the capacity of staff and volunteers in working with survivors and mental ill health.

The PCC is requested to approve an additional £4,194 from Community Safety Grant for the additional salary costs associated with the Sexual Violence Mental Health Practitioner as a result of the cost of living rise.
