EXECUTIVE SUMMARY:

The purpose of this report is to recommend approval of the purchase of Thorlux Smartsan lighting systems for Mansfield Police Station.

The current Thorlux lighting network (installed when Mansfield was a new build in 1999) was first recommended for full replacement in 2017 following a condition survey report.

Thorlux lighting systems are available via direct award from the ETL lighting framework: this framework was established within the NHS and is open to all public bodies to access. This provides a compliant route to market from a UK Contract Regulations perspective.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The Thorlux Smartsan light fitting is a product that provides longevity, smart monitoring of performance and sustainability. Each individual Thorlux fitting operates independently, thus providing the maximum energy efficiency across the whole installation network.

The fittings are also classed as fully maintained lights, which means that replacement parts, if needed, can be installed and prevents the need for the entire light to be disposed of: an historical problem of old design lighting fittings. This has a major improvement on efficiency and the reduction of waste.

As the fittings are linked via a hub, then energy performance data and reporting is provided to allow energy savings and efficiencies to be pursued. Additional functionality and controls such as time settings are all capable remotely via mobile tablet etc.


