TITLE:	Construction of new Nottinghamshire Police and Nottinghamshire Fire and Rescue Service Joint HQ at Sherwood Lodge.

EXECUTIVE SUMMARY:

The above project comprises the construction of a new building on the Sherwood Lodge site, together with alteration, conversion and improvements to existing buildings in order to accommodate a Joint HQ for Nottinghamshire Police and Nottinghamshire Fire and Rescue Service. The works are split between four work packages, the largest work package being the new build.

The new building which extends to approx. 5,300 square metres will comprise a new Control Room, Force Training Centre, a Training/Sports Hall, Conference facilities, Silver suite, Casualty Bureau, open plan office accommodation, Gym, Canteen and changing facilities.

The original budget for the project was agreed at £18.5m and Nottinghamshire Fire and Rescue Service are funding 18.64% of the capital costs up to a maximum of £3.5m.

Following the receipt of tenders for the new build works in April, 2020, which came in lower than expected, the budget was reduced by £639,000 to £17,861,000.

Since that time, additional costs have arisen. Details of these costs and the reasons for them are detailed in the attached confidential Report. The result of this is that it is necessary to reinstate the original capital budget of £18.5m, adding back £639,000.
