EXECUTIVE SUMMARY:

Commissioner Henry wishes to commission an independent victim support and restorative justice needs assessment for Nottinghamshire. The recommendations from the needs assessment and review will shape the commissioning of future victim support services and restorative justice services in Nottinghamshire.

Supporting Victims is a key priority for Commissioner Henry and she now wishes to commission an independent consultant to conduct an independent victim support and restorative justice needs assessment and to review the Nottinghamshire Victim CARE service. The needs assessment will inform future victim support and restorative justice services in Nottinghamshire.
