<p>The PCC is requested to confirm her verbal approval of the following additional spend from the 2021/22 Commissioning budget:</p> <ul style="list-style-type: none"> • £1,000 to Nottingham City Council as a contribution towards an International Women's Day event on 8th March 2022. • £500 to the Nottinghamshire Police Youth Outreach Team as a contribution to the Stephen Lawrence Day and Youth Awards ceremony Event.


INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>Nottingham City Council are planning an event on 8th March 2022 for International Women's Day. The event will include Domestic and Sexual Violence and Abuse workshops, with a particular focus on consent and women's safety. The PCC funding would be a contribution towards the set up costs associated with the event.</p> <p>The Nottinghamshire Police Youth Outreach Team are arranging a Stephen Lawrence Day and Youth Awards – Live Our Best Life Awards 2022 event which will take place on 19th April 2022. This event will celebrate the successes of young people in our community. Funding is required for a contribution towards performances, venue hire, a live DJ, food, refreshments and prizes. The PCC funding will be spent in 2021/22 prior to the event which will physically take place in April 2022.</p>
