#### **EXECUTIVE SUMMARY:**

Commissioner Henry wishes to commission a provider to undertake an Independent Review of Safety Provision in the Nottingham city night time economy (NTE) and subsequent recommendations for utilising Late Night Levy funds for addressing any identified gaps.

Commissioner Henry is requested to confirm her earlier approval of the dissemination of a Request for Proposals for the Independent Review of NTE Safety Provision to six organisations.

The work will be funded out of the Late Night Levy budget.

#### **INFORMATION IN SUPPORT OF DECISION: (eg report or business case)**

Commissioner Henry wishes to review safety provision in the Nottingham city NTE and to receive a set of recommendations as to how to utilise Late Night Levy funds for addressing any identified gaps.

The Commissioner is therefore looking for a Provider to undertake this assessment. The review is broad in scope and encompasses provision funded and delivered by both statutory and non-statutory agencies. The Commissioner has consulted with a range of partners to secure agreement to take part in the review.

Commissioner Henry will use the review to inform spending decisions in respect of funding received under the terms of the Nottingham Late Night Levy. This applies to both current funds and any future annual revenue.

A Request for proposals including a specification for the Independent Review of NTE Safety Provision has been developed and circulated to six potential organisations to respond. This is in line with Contract Standing Orders, which requires 3 quotes for activity up to £25,000.
