In relation to the above, please specify the category of the contracted services, i.e.:

- (i) advocacy, including independent sexual violence (ISVA) advice services
  - (ii) face to face services: counselling, emotional support, group support
  - (iii) forensic sexual assault services, including Sexual Assault Referral Centres (SARCs).
2. Plans, strategies or other public documents that relate to spending and investment in sexual violence/abuse services or sexual violence/abuse related services.

**In addition:**

- The Nottinghamshire PCC funds a wide range of domestic abuse services to the value of approximately £800-900k per annum. Support for honour based violence and forced marriage is integrated within these contracts. It is not possible to separate out the honour based violence and forced marriage support
- The PCC has set aside further funds in 2015-6 to tackle CSE, these funds are not yet committed
- The PCC is working with local authority and clinical commissioning group partners to co-commission new integrated sexual violence services, these will be procured during 2015 and operational from 1 April 2016
- The PCC's commissioning intentions for further sexual violence services will be published in early August
