## **Quarterly Report**

#### April - June 2021

During the first quarter of 2021/22 there were a total of 4224 people held in custody in Nottinghamshire.

The statistics in this report have been obtained through the Nottinghamshire Independent Custody Visiting scheme.

#### Number of Visits made by ICVs

Independent Custody Visitors recommenced physical visits to police custody in October 2020, following easing of Government restrictions in response to the pandemic. Physical visits increased during the first quarter of 2021-22 as Government restrictions eased and more volunteers become vaccinated. However, the scheme continued to undertake telephone calls with detainees during this quarter as part of its business continuity plan.


