TITLE: 2022-23 Grant Funding to the National Holocaust Centre and Museum

EXECUTIVE SUMMARY:

The PCC has been approached by the Hate Crime Steering Group on behalf of the National Holocaust Centre and Museum for funding to ensure the continuation of the Breaking the Cycle Youth Programme. Up to £6,000 is being sought to ensure the continuation of this programme for 2022/23.

The PCC is therefore requested to confirm her approval to use 2022/23 Community Safety Grant to:

• Award up to £6,000 to The National Holocaust Centre and Museum to fund the Breaking the Cycle Youth Programme in 2022/23.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The "Breaking the Cycle" programme seeks to reduce reoffending through educating perpetrators to understand the effect that social intolerance has on victims. Through reflection, participants will gain awareness of how their actions can affect others and the aim is that perpetrators develop a greater understanding and acceptance of diversity.

This 3-step programme involves a visit to the National Holocaust Centre and Museum (NHCM), where an educator specialising in holocaust education expands awareness about the implications of prejudice, racial intolerance, discrimination and indifference. Learning methods will aim to stimulate critical thinking and reflective learning in the context of individual responsibility. Learning from the Holocaust will be differentiated as appropriate according to the specific strand of hate crime committed. The visit to NHCM will culminate in a talk from a Holocaust survivor, which will challenge every participant to evaluate deeply held concepts and attitudes.

This learning programme has been in place at the National Holocaust Centre and Museum (NHCM) since 2014, with very positive feedback from schools, parents, police and council staff. A programme that youth participate in on referral, it is also one of the few programmes available

to address prejudicial behaviour by working with perpetrators – mostly youth between the ages of 10 - 17.

Through facilitating perpetrators to reflect on their views and values the aim is to reduce reoffending, which in itself will contribute to reducing hate crime.
