Thank you kindly for the comments and feedback you have shared on behalf of the Police and Crime Panel regarding my Annual Report for 2022/23. I am grateful for the time that you have taken to assess the report and in providing your ongoing support and constructive scrutiny.

I acknowledge that the sustained reductions seen in anti-social behaviour, as measured by Nottinghamshire Police incident statistics and our Police and Crime Survey, have not been reflected in all localities across Nottinghamshire. Please be assured that we are working with partner agencies via the ASB Taskforce to identify and respond to locally emerging ASB issues, adopting recognised best practice and tools and problem-solving techniques developed as part of the Safer Streets programme. As you have highlighted, the work we are undertaking to map key partnership agendas and their alignment to the Police and Crime Plan will be instrumental in determining how and where my office and I engage with the sector to ensure that my plan and statutory functions are effectively discharged. We look forward to sharing more information on this as the project develops.

Driving improvements in public trust and confidence in the police remains one of my core priorities and I welcome your ongoing support and challenge in ensuring our communications, activity and resource allocation is receptive to emerging trends in this area.
