**TITLE: OFFICE OF THE POLICE AND CRIME COMMISSIONER RESTRUCTURE****EXECUTIVE SUMMARY:**

The current Executive staffing structure was approved by the former Police Authority in October 2010. This structure has remained largely unchanged since it was agreed. Interim staffing arrangements were put in place prior to the arrival of the Commissioner to enable him to discharge his legal responsibilities from day one. A review has been completed of the core functions and responsibilities of the Commissioner as defined by legislation, protocols and financial code of practice.

The business case sets out a new staffing structure for the Office of the Police and Crime Commissioner.
