TITLE: SALE OF FORMER ROUNDABOUT YOUTH CENTRE, SOUTHCHURCH DRIVE, CLIFTON

EXECUTIVE SUMMARY:

In February, 2012, the former Police Authority agreed the sale of the above site to the Hope Church (Nottingham) for £200,000. The site had been purchased from Nottingham City Council for £106,000 in March 2010 for the construction of a new Police Station site. Following the Government's Comprehensive Spending Review in October 2010, the project was cut from the capital programme and the Police Station has now moved to the former Clifton Medical Centre on Farnborough Road which is leased from the Nottinghamshire Fire and Rescue Authority.

The purchase has proceeded extremely slowly with the purchaser having to arrange finance and the cost of conversion of the building for the purchaser's requirements being higher than anticipated. Part of the site is required for the Tram extension and it has been extremely difficult to obtain definite information regarding the exact boundaries of land which will be transferred for the Tram extension. The purchaser has not been willing to complete the purchase without this information.

Furthermore, the purchaser has withdrawn the offer of £200,000 and indicated that the maximum that they are willing/able to pay is £180,000.

The Force's Estates Consultants, Lambert Smith Hampton have recommended that this offer be accepted.

The purchaser has all of the necessary information now and is willing/able to proceed quickly, subject to formal agreement of the revised sale price.
