TITLE: County Substance Misuse Contract

EXECUTIVE SUMMARY:

The Commissioner is contributing financially to the Contract for substance misuse services in Nottinghamshire county which will be re-commissioned in early 2014. A report has been prepared with supporting information. This is currently classified as confidential due to commercial sensitivity and will be released at a later date.

It is recommended that the Commissioner requires specific stipulations within the contract relating to Criminal Justice Substance Misuse delivery and regarding his financial commitment in order to ensure continued multi agency working based around the successful IOM model. This is required to meet the aims of the Police and Crime Plan and to future proof against the impact of the ongoing Transforming Rehabilitation agenda.

- That the contract stipulates a requirement that each year of the contract the new provider is required to financially support the conurbation service users arrested in the city through a financial contribution to the city service providers broadly at the same level as 2012/13 but commensurate with evidenced assessed need see associated report for details
- That throughout the contract the current level of funding allocated for Crown House is retained by the Commissioner to allow for future influence over estates see associated report for details
- That at a minimum 2% year on year efficiency savings are required from the provider during the course of the contract

- That the Commissioner requires performance management linked to criminal justice services users to be separately measured and that the following additional performance measures are included within the contract:
 - •55% DRR successful completion rate
 - No more than 25% reoffending per month within cohort
