# TITLE: Regulation A19 Appeal Against ET Decision

#### **EXECUTIVE SUMMARY:**

The Police and Crime Commissioner for Nottinghamshire is asked to consider a decision with regards to lodging an appeal against the Employment Tribunal ruling that the Force's decision to make use of A19, requiring officers with more than 30 years' pensionable service to retire, was unlawful.

On 5<sup>th</sup> February 2014 the Tribunal found that the use of Regulation A19 breached age discrimination laws. Nottinghamshire has since taken further legal advice and has been advised that there are grounds for an appeal, based on points of law. The Tribunal Rules give Forces 42 days in which to lodge an appeal.

Based on the further legal advice received, it is therefore recommended that Nottinghamshire lodges an appeal to the Employment Appeals Tribunal (EAT) along with the four other Forces, Devon and Cornwall, West Midlands, North Wales, and South Wales.
