TITLE: Business Case ICT Telephony Solution**EXECUTIVE SUMMARY:**

Nottinghamshire Police has a Siemens telephone system providing the main Force telephony for which the end of supported life has been announced for 2017. Nortel Meridian phone systems are used in the Force control rooms which have an end of supported life for 2016.

It is recommended that the Force operates two telephone systems (one serving the force and the other the Control Room) that are independent but interconnected. The Force and Control Room telephony can be delivered by the same, single, vendor or by separate vendors.

The attached Business Case has been considered by the Telephony Project Board, Corporate Services Board and Force Executive Board, all of whom have accepted Option 3 "CISCO force wide with CISCO with UCCE in the Control Room " as the most suitable solution to meet the current and future needs of Nottinghamshire Police.

This business case is seeking authority to commence the telephony upgrade for which £1.45M has been allocated to the Information Services budget.
