### **TITLE: Payment of Police Pensions**

### **EXECUTIVE SUMMARY:**

Nottinghamshire County Council administers the payment of police pensions for Nottinghamshire Police; is the administering body for the LGPS in Nottinghamshire and, until April 2013, administered payment of pensions for Notts Fire and Rescue service.

An audit undertaken by Leicestershire County Council on transferring the administration of the Notts Fire Service scheme to Nottinghamshire County Council has identified a number of discrepancies in the payment of the post 1988 GMP to those who have reached state retirement age.

**Impact on payment of Police Pensions** – Due to the fact that the same payroll system was used to pay Police pensions, a similar exercise has been undertaken for police pensioner's payroll and has identified the same issue. The issue appears to have occurred around 2005 possibly following a Notts County Council system upgrade.

This means that there has been a total overpayment of £52,000 towards police officer pensions. It is suggested that the approach to rectifying this situation is for Nottinghamshire County Council to reclaim the £52,000 of overpayment back from the police pensioner's future payments.

This will involve correcting the annual pensions. Then applying 2.7% (annual increase) to the correct pension figure and identifying the difference to the amount currently paid – this is then an increase to their pension for 2014. For all those affected except 1 person this will still result in an increase to their pension for 2014. For this individual the difference is a deficit of 12 pence that will be manually adjusted. Nottinghamshire County Council Pensions department will write to all pensioners to confirm what they have done and explain why. This is the same approach taken with the Fire Service Pensioners.

**Impact on Home Office funding** - The return to the Home Office regarding Home Office funding will be adjust to account for the overpayment in the 2013/14 return and the recovery in 2014/15 financial year.
