CAPITAL FUNDING REQUEST

SCHEME NAME (consistent): Crime Lites

SCHEME PURPOSE (brief): To provide an improved CSI service delivery SCHEME DETAILS (brief):

CrimeLites are specialist light sources used for CSI examinations. They emit high intensity light at specific wavelengths which when used correctly can cause trace forensic evidence to fluoresce, allowing for identification and prompting recovery. They are used for searching for a variety of evidential types including seminal fluid, blood, hairs and fibres. When used alongside the blackout tent above they can be used in-situ at crime scenes, particularly on deceased persons, increasing the forensic yield dramatically

The CSI Department currently hold in stock:

 4 sets of the CrimeLite1, coloured light sources each with one full set of goggles.

Whilst the above are still currently functioning they are approximately 7 years old and have now been superseded by new models. The newer models provide greater efficiency in burn time and also are available at a much higher intensity.

The following items will resolve this issue:

Crime-Lite 82S

- 1 x Full sets of Crime-Lite 82S Colours (8 units) per base (MIV)
- Charging Units and Spare Batteries for the above
- 3 x Full sets of Goggles (8 units) per base (MIV)
- 1 x Full sets of Coloured Filters for Nikon D7000 (5/6 units) per base (MIV)

The benefits of purchasing this equipment will be:

- Increased ability to record and recover trace forensic evidence at scenes
- Expansion of range of examinations conducted by CSI, rather than

requiring support from external or internal forensic suppliers

 Versatility to allow use alongside specialist departments (additional goggles allow safe effective use by all parties

Currently there is £7,000 equipment contingency capital budget available which can be allocated towards this project and £7,000 remaining from the vehicle purchase budget which could be allocated. Therefore this request only requires additional funding of £14,000
