TITLE: Replacement Building Access Control System**EXECUTIVE SUMMARY:**

Nottinghamshire Police has concluded that the current Bewator swipe card system deployed to provide authorised individuals with access into Force sites, buildings and rooms, while preventing unauthorised individuals from gaining access, is now at the end of its life expectancy. In addition to the swipe card system the Police key 'patent' has expired and means that keys can be copied more easily than when the 'patent' restricted copying. The card and swipe reader equipment that is used on the majority of the gates and doors is failing on a regular basis and replacement parts are not available, following the manufacturers continued upgrading of equipment and they have stopped making replacement parts. The current system used by Nottinghamshire Police is also not regarded as being adequately secure for modern policing and is not flexible enough to provide good access for regional Police teams.

DECISION:

Nottinghamshire Police seeks approval of the business case to carry out the replacement of the swipe card access control system, and the Police key locks throughout the Force at an estimated capital cost of £545,282 and in addition to the capital fund there will be a one off £10,000 revenue fund required to cover the cost of additional staff in Estates & Facilities to produce the replacement photo ID and swipe card for every member of staff. .

There is within the capital programme for 2014/15 and 2015/16 a sum of £420,000 already allowed for this project and so the Force seeks permission to increase this funding in line with the latest estimated cost.
