**TITLE: Dragons Den Style DV Schools Awareness Project**

#### EXECUTIVE SUMMARY:

We awarded £5,000 of funding during 2013-4 to Nottinghamshire County Council to deliver a schools based Dragons' Den style awareness project. In addition, the Ashfield Community Safety Partnership allocated £1,500 of Police and Crime Commissioner funding to the project.

During the project, Year 10 students from 6 schools in Ashfield were invited to produce and communicate an awareness raising campaign for other young people aged 13-15 years. The winners of the Dragons' Den received a £1,500 prize fund for their school. It was agreed by the Chief Finance Officer in January 2014 that a one off exception could be made to ensure that the project could spend 2013-4 funding during the school academic year.

The winner of the £1,500 prize fund was Sutton Community Academy. The Academy requested to spend the funding on recording studio for the students. It confirmed that the recording studio is intended for the sole use of the school and will not be hired or sold for profit.

#### INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

In line with the grant agreement for the project we have made a contribution to the Academy for it to use to provide activities for young people. The Chief Finance Officer gave verbal agreement to make a revenue contribution to capital when the request was made by the Academy in May 2014.




