TITLE: Broxtowe Police Station

EXECUTIVE SUMMARY:

As part of the Productivity programme a phase 3 rationalisation of the Estate has been developed to contribute to the delivery of a number of the force's strategic objectives set out in the Policing Plan 2011-15 and to deliver further target savings by reducing the number of buildings, running and maintenance costs. To achieve these savings all buildings within the estate are being reviewed.

The review of Broxtowe Police Station is part of the Estates Rationalisation Phase 3 work stream to provide a fit for purpose, flexible and sustainable estate enabling savings to be delivered of £2.4m over 3 years.

Options for consideration are;

- 1) Remain at Broxtowe Police Station with a refurbishment.
- 2) Joint Shared Service Centre with Nottingham City Council.

The recommended option is **Option 1** which has the following advantages over Option 2:-

- Cheapest option.
- As the main buildings affected are owned by Nottinghamshire Police we can control timescales, budget etc.
- Able to deliver the scheme quicker.
- Adequate car parking.
- Less risk than Option 2.
- Option 2 requires a long term commitment to significant costs.
- Easier to make changes in the future should policing requirements change.
- Both options allow co-location and joint working with Nottingham City Council Community Protection. There are no additional operational partnership benefits of co-locating with a Library and sheltered housing accommodation.


