TITLE: HOLMES 2**EXECUTIVE SUMMARY:**

This is a renewal of an on-going requirement for HOLMES2. HOLMES2 is used primarily by EMSOU-MC to investigate Major Crime. Recommend the approval for the award of contract for Holmes 2 for a further three years.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The current contract is with Unisys.

The Holmes 2 Contract was previously hosted and procured by Leicestershire Constabulary as a Regional requirement and recently a decision was made transferring the management of this contract to EMSCU. The future Regional Licence requirements were reviewed by EMSOU-MC and later ratified at a meeting containing the five Chief Constables.

Holmes 2 Cloud Readiness and Transition Service for the Regional licences, support and maintenance to be provided by Unisys for the period of 29th September 14 to 25th September 15 for the total contract value of £92,347.55.

Holmes2 Application (v16) Service including a Ruby Level of Service for 175 Licences within the Region for the period of 26th September 15 to 25th September 17 for the contract values of £219,450.00 on 26th September 2015 and £135,800.00 on 25th September 2016

The Home Office have recommended that all Forces renew their existing contracts using the G-Cloud Framework provided by the Crown Commercial Service (CCS). This particular requirement is on behalf of the five East Midlands forces adheres to that recommendation.

The contract rates defined on the G Cloud Framework by Unisys are fixed and constant to all UK Police Forces and are non negotiable.


