TITLE: For the service provision of 'The Voice' survey and Police Budget and Precept Participatory Groups for Nottinghamshire

EXECUTIVE SUMMARY:

The Commissioner invited tenders for the supply of services in respect of conducting social research across Nottinghamshire on the following:

- Priority Plus Areas which will include telephone / face-to-face interviews.
- Nottinghamshire Police budget and precept participatory groups (one Women's group, one group with member from Black, Minority, Ethnic and Refugee communities, one group with Nottingham City residents and three groups with County residents.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

The aim of the Priority Plus Area survey and any supporting face-to-face interviews are to widen the understanding of the potential and support for residents to identify those needs, including existing and emergent needs, and ideas to improve safety and quality of life in neighbourhoods. The piece of work will also compliment the City and County's Annual Surveys used by the Commissioner as part of the Police and Crime Needs Assessment, by providing a 'deep dive' into the issues that matter and are of concern to residents within the Priority Plus Areas. The estimated cost will be no more than £20,000.

The Police budget and precept participatory group's aims are to produce qualitative findings to support the 2015/16 Police budget setting process and to inform the refreshing of the Commissioner's Police and Crime Plan. The estimated cost will be no more than £10,000.


