### TITLE:

Establishment of a Digital Investigation & Intelligence (Cyber) Unit integrated with FIB and re-located to FHQ

### **EXECUTIVE SUMMARY:**

The business case seeks approve to relocate the Digital Investigation and Intelligence (Cyber) Unit integrated with FIB to FH.

This links into the approved business case for the Digital Investigation Unit relocation to FHQ releasing accommodation space at Holmes House and provides a centrally located office under the same management and delivers the benefits identified in both business cases.

The preferred Option 5 also requests the establishment of 3 new DMI posts to allow the unit to deliver the full benefits of the business case in a growth area. The Joint Local Policing and Specialist Services Programme Board supported the proposal and requested that further work be conducted with the Delivering the Future programme to find where the posts can come from.
