TITLE: Relocation of Digital Investigations Unit (DIU) from Holmes House to FHQ.

EXECUTIVE SUMMARY:

- The Digital Investigation Unit (DIU) needs to be relocated to FHQ in order to support a developing infrastructure that will provide security for the digital data being created and stored as a result of 'dead box' examination.
- The department has a bespoke and fairly high maintenance set up, therefore the closest locality possible to the Information Services department and the main force server is required.
- The unit currently resides at Holmes House and the data is not sufficiently safeguarded against loss as there is no backup regime in place. The infrastructure currently in place is struggling to cope with the demands of the increasing data handling and storage requirements placed upon it.
- The IS department have conducted an assessment of the situation and are of the opinion that the only viable solution includes a move to FHQ due to proximity requirement for the force server system and their own physical support network.
- Relocation to FHQ carries with it a number of other ancillary benefits which most notably include placing it closer to the centre of demand generated by the divisions.
- The preferred option is to relocate the DIU to the main building at FHQ, currently used by EMSOU-FS Identifications Bureau. The space will become available once EMSOU-FS relocate to the Arrow Centre.
- The preferred option (over and above the IS costs already budgeted for) requires an estimated facilities budget of £146,655
