**TITLE: Nottinghamshire Police, Provision, Installation and Maintenance of an Access Control System**

### **EXECUTIVE SUMMARY:**

1. The purpose of this report is to seek approval for the award of a contract to Kings Security Systems Ltd under the terms of the West Yorkshire Police Framework for the Provision of a Physical Access Control System (PACS) Ref:WYP/PROC/2011-397 which allows for direct award.
2. The contract will provide a state of the art, cost effective and reliable Access Control/Security Management System, scalable to meet the current and future needs of Nottinghamshire Police, whilst improving staff and visitor confidence.
3. The system will meet the DDA objectives and obligations at all of the forces sites without compromising the overall solution.
4. The system will also reduce organisational risk, improve security, reduce maintenance issues and costs, and ensure the safety and security of employees undertaking their roles and deliver a service to the public whilst taking advantage of new technologies and improving links between systems.
5. The new system will ensure that issues associated with the current system are minimised, ensuring the functionality can be enhanced, aligned with other force systems, and allow for regionalisation.
6. The maximum possible contract value will be £481,265.07 (capital), although no guarantee as to the final amount has been made as this figure will reduce throughout the contract term as the force reduces its estate. The contract will be for a term of 3 years with options to extend for a further 2 x 12 periods.
