TITLE: Response Policing Business Case Addendum – Watnall Road, Hucknall.

EXECUTIVE SUMMARY:

The Response Hub serving Ashfield South and Broxtowe North

When the Response Policing Business Case was approved it was recommended that the response hub that covers the Hucknall and Eastwood area would be based at the Driver Training School, Watnall Road, Hucknall.

Until now it has not been possible to confirm the arrangements as an assessment was required of the building to confirm that there was sufficient space, to determine any costs that might be associated and to confirm that technically the location would be suitable for our needs.

It has now been established how the Response team could be incorporated within the building in a way that will not displace any Learning and Development Staff or their ability to deliver training. The plans have been reviewed by Learning and Development Team colleagues and meet with their approval.
