TITLE: Procurement of consultancy support to review victims services

EXECUTIVE SUMMARY:

Following procurement, the Commissioner funded a number of victim support services for 2015-6, which are delivered by Victim Support, Remedi, Integritas Advocacy and Age UK. The Commissioner must procure new victims services for the 2016-7 financial year and requires some independent consultancy support to advise on the most efficient and effective model for future services.

The Commissioner will procure the consultancy service through open tender, with support from East Midlands Strategic Commercial Unit (EMSCU).

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

A review of the Victim Support service was always planned for June/July 2015. In addition, there is evidence to suggest that current services are insufficiently targeted to the victims who need the most help; and collectively they may not providing best value for money for the Commissioner. The Commissioner will procure new victim support services in 2016. He wishes to move to a more targeted, effective and efficient model which provide tailored outcome focused support for the victims that need it most.

The objectives of the review are to:

1. Gain feedback on current victims support services in Nottinghamshire to answer the question: "Are victims getting the help they need from victim support services?"
2. Produce a strategic assessment of victims in Nottinghamshire.
3. Capture learning from new models of victims' support services from other police force areas.
4. Identify improvements and efficiencies in victims support pathways.
5. Recommend a new delivery model for victim support services.

There is insufficient capacity within Nottinghamshire Office of the Police and Crime Commissioner to complete the review in the required timescale (by the end of October 2015). In addition, there are advantages to the review being conducted by an independent agency.
