**TITLE: Response Policing Business Case Addendum – Ranby, Bassetlaw.**

**EXECUTIVE SUMMARY:**

**The Response Hub serving Bassetlaw**

When the Response Policing Business Case was approved it was recommended that the response hub that covers the Bassetlaw area would be based at new accommodation at a central location in Bassetlaw that is served by good North / South / East / West road networks.

Until now it has not been possible to confirm the arrangements as negotiations were needed with perspective landlords an assessment was required of any building to confirm that there was sufficient space, to determine any costs that might be associated and to confirm that technically the location would be suitable for our needs.

It has now been established how the Response team could be incorporated within a building owned by the Ministry of Justice and located on the opposite side of the road from HMP Ranby near to Retford.

The building will be shared with the Prison Service with the police having exclusive use of part of the property. The arrangements will also provide parking for both police and staff vehicles and to locate a bunkered fuel storage tank.

The purpose of this report is to seek agreement for the release of funding and to enable the negotiation of a lease and contracts to be completed and for necessary planning approvals to be sought.
