TITLE: Replacement of Digital Investigations Unit Equipment

EXECUTIVE SUMMARY:

The purpose of this project is to secure capital funding for the replacement of current forensic hardware with a new generation of computers to ensure the future operating efficiency of the Digital Investigation Unit (DIU).

Within the DIU, the majority of existing forensic workstations have reached the end of their useful life (5 years old). The next generation of hardware will better support faster and more efficient processing of ever growing device numbers and data volumes. These newer machines will also allow best and most efficient use of the range of forensic software deployed within the DIU.

A number of computers need to be replaced due to persistent failures and their inability to undertake sufficiently fast processing of increasing data volumes. The current contract for maintenance on the most recently purchased machines has expired. Advances in digital technology, increases in devices submissions and growing data volumes require the latest technology to assist with the heavy processing tasks undertaken. Some of the existing equipment is now obsolete and increasing amounts of digital investigation time is being lost to maintaining and repairing ageing equipment.
